Irish History #82

Irish History #82 – When the Guns Went Silent in the Irish War of Independence

Northern Ireland celebrates its 100th birthday this year. Curiously, the exact date is the subject of debate. The British Parliament's 1920 Government of Ireland Act set up two home rule parliaments, one for the six counties in Ireland's northeast and another for the 26 counties in its south and northwest. The Act came into effect on May 3, 1921. Some view May 3 as the centenary anniversary.

Others believe the opening of the Northern Ireland Parliament on June 22, 1921 is the real birthdate. The Orange Order recognizes both dates as Northern Ireland's beginning. Seems like a confusing and uninspiring way for the statelet to start.

On June 22, King George V opened Parliament with a speech that appealed for "Irishmen to stretch out the hand of forbearance and conciliation, to forgive and forget, and to join in making for the land which they love a new era of peace, contentment, and good will." British Prime Minister David Lloyd George used the King's call for reconciliation to convince hawks in his cabinet that now was the right time for a peace initiative.

Just 8 months earlier, Lloyd George said "we had the murder gang by the throat," referring to the rebels. The British "frightfulness policy" (i.e., the ruthlessness of the Black and Tans and Auxiliaries) for dealing with Ireland was supposedly working. But Michael Collins's stunningly successful operation (See Chapter 77) on Bloody Sunday made that a questionable supposition. Also, the lesson from Terence MacSwiney's death on hunger strike (See Chapter 71) taught the British multiple things. First, settling the Irish question would require more than a military victory; second, thinking military might alone could defeat the Irish desire for independence was a pretense; and third, sending more British troops to Ireland was not the answer.

Military leaders saw two available options: either go "all-out" or "get-out." Perhaps, the first option - the application of "unstinting force" and "iron" repression - could achieve the objective? But no cabinet member favored that approach. Nor did they favor getting out. This meant they would continue to persevere with the existing policy, where the outcome was uncertain, or try something altogether different.

What happened, according to cabinet member Winston Churchill, was a "complete and sudden reversal of policy." Within a month's time, the entire power of government being used to "hunt down the murder gang" was changed to the goal of "a lasting reconciliation with the Irish people." Churchill advocated making Sinn Féin "the fairest offer" coupled with drastic threats of "a tremendous onslaught." A majority of the cabinet agreed with this new approach.

Lloyd George acted quickly after the King's speech. He made

a public appeal to Irish President Eamon de Valera to attend a peace conference, so that the King's call "for reconciliation, for peace in Ireland, shall not have been made in vain." He invited de Valera and Northern Ireland Prime Minister James Craig to a conference in London "to explore to the utmost the possibility of a settlement." Although Lloyd George felt it may have been more productive to negotiate with Collins, he believed the British public would have greater respect for the peace process if the head of the Irish rebel government (de Valera) was involved instead of a man with blood on his hands (Collins). Lloyd George also mistakenly believed de Valera was the more moderate of the two.

De Valera and Craig had first met at an unfruitful meeting a few weeks before Lloyd George's invitation and after Northern Ireland became a six-county statelet with its own parliament. For Craig, that was good enough. So, he told Lloyd George it was up to him as PM and Sinn Féin to settle things in which he was not involved. He said, it was for "Mr. de Valera and the British people to come to terms regarding the area outside of which I am Prime Minister." Craig made his intention clear. He would not be a party to peace talks.

Valera demurred in responding to the invitation. He was aware of reports that the IRA was running out of arms and ammunition. How much longer the rebels could sustain their guerilla war was a real question. So, he expressed an earnest desire to help bring "about a lasting peace," but said he could not fully reply until after meeting with the political minority in Ireland (i.e., Craig and the unionists) to discuss "Ireland's essential unity." Craig was not interested in meeting de Valera on those terms, and de Valera - fearing it would be viewed as an acknowledgement of partition - was not interested in attending a tripartite meeting that included Craig. While delaying his response to Lloyd George's invitation, de Valera demanded a truce (with the rebels permitted to hold onto their arms) before negotiations began.

Lloyd George agreed to de Valera's conditions and to hold talks without Craig. He proposed a truce which the cabinet approved on July 9. This led de Valera to agree to a meeting. The truce came into effect on July 11, and the guns went silent. A war weary Irish people were happy to see a truce, and "gunmen emerged from their hiding-places and strode the streets of Dublin as the leaders of a nation."

Collins did not join those cheering the truce. He feared rebels would be vulnerable when they came out in the open. He noted, "it is extermination for us if the truce should fail," and the rebels will be like "rabbits coming out of their holes." This fear stayed with him during the intense weeks of negotiation that led to the Anglo-Irish Peace Agreement. But that is a story for another day.

De Valera snubbed Collins by excluding him from the delegation he brought to London. On July 14, Lloyd George and de Valera met in the Cabinet Room on Downing Street. During a week's time, the two leaders held many lengthy meetings alone. De Valera viewed the discussions as being "between us two as principals," and he excluded his delegation from the talks. His approach was the opposite of the negotiations that hammered-out the terms of the Anglo-Irish Peace Treaty. De Valera avoided attending those negotiations, by choosing not to go to London.

Lloyd George, known as the Welsh Wizard, was a highly skilled negotiator. He found de Valera to be "impossible" to deal with, and described their discussions as being similar to "sitting on a merry go-round and trying to catch up [with] the swing in front." Near the end of their talks, Lloyd George placed an offer of "Dominion Home Rule for Ireland" on the table. De Valera rejected it; he demanded complete independence and repudiated the Crown. This generated a written reply from Lloyd George that stated: "the British government could discuss no settlement which involves a refusal on the part of Ireland to accept our invitation to a free, equal, and loyal partnership in the British Commonwealth under one Sovereign." The negotiations reached an impasse before they even started talking.

After the meetings concluded, Lloyd George pivoted in his correspondence with de Valera. He asked de Valera whether he was prepared to attend a peace conference on "how the association of Ireland with the community of nations known as the British Empire can be reconciled with Irish national aspirations." De Valera replied affirmatively in a letter, but also wrote that "[o]ur nation has formally declared its

independence and recognizes itself as a sovereign State." Lloyd George, taking that response as a no, cancelled future conferences.

Backpedaling, de Valera took the initiative to reopen discussions, and suggested to Lloyd George that a treaty allowing Great Britain and Ireland "to work together in free and friendly co-operation in affairs of common concern" could resolve the dispute between the two nations. The British then made a fresh offer to hold a peace conference. Under this proposal, the ground rules had not changed. The conference would be run along the same lines presented in Lloyd George's correspondence to de Valera. This time, the Irish accepted.

Partition and an Irish Republic were important for the Irish side. Yet, it should have been obvious from the start that a republic was already lost. De Valera should have known that the chance for success was close to nil, which likely explains his absence during the final negotiations. Churchill found it "significant that Mr. de Valera remained in Ireland," while the plenipotentiaries he selected where in London handling the negotiations.

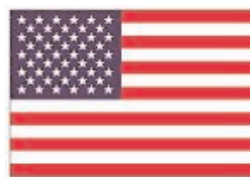
