# Irish History #75

## Black and Tan Reprisals and Burning Down Cork

Black and Tan recruitment in Great Britain increased during the summer of 1920. More than 500 enlisted. An economic recession that fell led to a big surge, 1100 joined the so-called police force in October alone.

The British viewed the IRA as a "murder gang" of terrorists and revolutionaries. The British had 50,000 soldiers garrisoned in Ireland. Yet they saw the conflict in terms of fighting crime not achieving military objectives. And getting "criminals" was a job for the police. This strategy put the police on the front line in Irish War of Independence.

Basic law enforcement training for the Black and Tans occurred in Gormanston, Co. Meath. They were given dark green and khaki clothing, which they wore as uniforms. The name Black and Tans came from these distinctive colors.

The training was limited. It lasted only 3-4 weeks. After which, Black and Tan recruits were stationed throughout the Irish countryside alongside members of the Royal Irish Constabulary (Irish police force). They were "paid 10 shillings a day and more or less given a free hand, to shoot, loot and carouse as they wished," according to Tim Pat Coogan.

The new force was both ill-trained and undisciplined. In September, after a constable was shot and killed in Balbriggan, Black and Tans from Gormanston Camp attacked the village. They burned-down a hosiery factory that employed over 100 people, and more than 30 shops and homes. They also bayoneted two local republicans to death. The Balbriggan attack was a sign of what was to come: reprisals and extrajudicial killings by crown forces. This was the legacy of the Black and Tans in Ireland.

The British government considered reprisals to be a necessary counter-insurgency tactic against IRA attacks on the government, such as burning police barracks, shooting police officers, assassinating informers and killing soldiers. In formulating the policy, the British Cabinet sought to punish the Irish and make them "feel the effect of the

campaign of murder and arson along economic channels."

What happened in Balbriggan was repeated in five other towns in a week's time, which shows the importance of the policy to the British. The most destructive episode of Black and Tan reprisal occurred a few months later in Cork.

As we know from previous chapters (See Chapters 70 and 71), Cork was a hotbed of IRA activity. The IRA ambushed police and military forces in Cork city for several weeks. When six members of the IRA ambushed a patrol of Auxiliaries at Dillon's Cross with grenades and gunfire, one Auxiliary was killed and a dozen were wounded. The attack was over quickly, and the IRA men made their escape with no injuries.

That IRA attack gave crown forces an excuse to sack Cork. Shortly after, police responded to Dillon's Cross. They forced occupants from their homes and demanded information. Receiving none, they burned six homes to the ground. Then, crown forces assembled on St. Patrick's Bridge over the River Lee in Cork City. They moved down St. Patrick's Street firing indiscriminately, breaking shop windows and setting fires with cans of petrol.

Black and Tans and Auxiliaries prevented the Cork Fire Brigade from responding. They cut hoses, turned-off hydrants, and fired shots over the heads of firemen.

Fires blazed, spread to adjacent streets and wrapped the city in smoke. Fifty-seven premises, including City Hall and the adjoining Carnegie Library, were totally destroyed. Damage was spread over 5 acres, at an estimated cost was 2.5 million dollars. More than 2,000 people lost their jobs.

The conflagration is described in Peter Hart's book *Rebel Cork's Fighting Story*. "The awesome roar of raging flames rose like the sound of a great wind above the obscene clamor that marked the flowing tide of destruction. Great pillars of fire produced marvelous combinations of brilliant color and wreathing form; the

crashing of roofs and walls sent up effervescent showers of glowing sparks, over the whole city there hung a dense, dull pale of heavy smoke." The city skyline was changed overnight by fire. Debris filled the streets. Buildings smoldered. And the stink of burning was everywhere.

Hart aptly described the conduct of crown forces in the following manner: "Auxiliaries, Black and Tans, soldiers - some were half drunk, many were shouting and jeering, all were wild, furious, savage, exultant in the urge to destruction." They swarmed city center, where an "uncontrolled orgy of burning and looting began." The wanton destruction of Cork was intended to make a statement to the IRA. Payback!

As if burning down Cork was not enough, crown forces had one more point to make. Before the night ended, two members of the IRA were mistakenly accused of the Dillon's Cross ambush. Although unarmed, they were shot to death in their bedrooms. Their murderers wore military uniforms.

The extensive and utter destruction of Cork raised pointed questions from the British press. Sir Hamar Greenwood, the British government's Chief Secretary for Ireland, attempted to obfuscate. He falsely denied that British forces were involved in burning Cork. He placed blame for the fires on the IRA. The British government commissioned an "impartial" military investigation but never published a report.

The Irish Labor Party and Congress of Trade Unions gathered eyewitness accounts from 61 people. A report entitled "Who Burnt Cork City?" was published. It detailed "how drunken Black and Tans and Auxies

[Auxiliaries] attacked firemen, set fire to buildings, looted and attacked civilians." Despite the British government's attempt at misinformation, history suggests the Irish Labor Party and Trade Unions got it right.

Cork was burned down by crown forces.




