

Irish History 59 - Michael Collins Reminds the British of 700 years of Irish History

In the last chapter, we learned that Eamon de Valera and Michael Collins performed different roles during the Irish War of Independence. As political chieftain, de Valera went to the U.S. to gain publicity for Ireland's fight for self-determination and to raise funds to support it. As head of the Supreme Council of the Irish Republican Brotherhood, Collins remained home to prosecute the war. This separation was a harbinger of things to come between them. Their split had deadly consequences for a fledgling Irish nation.

After a truce was called in the Anglo-Irish War, de Valera appointed an Irish delegation to engage in peace talks with the British. He named Collins to the delegation. For two months, peace discussions were held in London. An agreement to end the war was reached on December 6, 1921. Collins knew that in agreeing to the deal, the Anglo-Irish Treaty, he was signing his own death warrant.

The British had threatened to wage all-out war on Ireland, if the Treaty was not signed. As the man who led Ireland's fight against the British, Collins knew the country was unable at that point to withstand British belligerence. Many would die in a losing cause. Too many in Collins' mind, so he signed the Treaty which created the 26 county Irish Free State. It did not include the six counties of Ireland's northeast.

On January 7, 1922, the Dail approved the Treaty by a vote of 64-57. De Valera and his followers walked-out. They were called-out by Collins on the Dail floor. He described them as "[d]eserters all to the Irish nation in her hour of trial." He added, "[w]e will stand by her."

Nine days later, the British handed their center of administrative authority in Ireland, Dublin Castle, over to the Irish Free State. Collins represented the Irish Free State government at the hand-over ceremony. There are various anecdotes about what was said there. The most popular one is that the British Lord Lieutenant Viceroy chided Collins for arriving late, saying "[y]ou are seven minutes late Mr. Collins." Supposedly, Collins famously retorted: "We have been waiting 700 years; you can have your 1171

Henry II invaded Ireland. Dublin Castle was made the center of administration of the English Pale.

- 1366—** The Statutes of Kilkenny were enacted, making English the official language in Ireland.
- 1536-1541—** The Irish Parliament passed the Act of Supremacy, which recognized the King of England as the head of the Church of Ireland. Henry VII was declared the King of Ireland.
- 1607—** Gaelic chieftains were defeated in the north. They left Ireland for the European continent in the "Flight of the Earls."
- 1610-1640—** 40,000 Scottish and English settlers received land grants in Ireland during the Ulster Plantation. Four million acres of land were transferred from Irish farmers to settlers.
- 1641—** Catholics in Ulster rebelled and regained confiscated lands. They took revenge on settlers by slaughtering thousands. Sensational news accounts in London referred to the rebellion as "frightfulness."
- 1649—** Gains made by the Irish during the rebellion were reversed by Oliver Cromwell. He massacred the garrisons and civilians at Drogheda and Wexford. He took land from the Irish who opposed Parliament, and awarded it to English and soldier settlers.
- 1685-1689—** Catholic King James II undid the Cromwellian land settlement by returning land to its former Irish owners. James II's army failed to take the city during the "Siege of Derry."
- 1690—** William of Orange defeated James II in the Battle of the Boyne. Ireland began to be controlled by the Protestant Ascendancy.
- 1692-1705—** Enactment of Penal Laws forbade Catholic priests from saying mass, and disqualified Catholics from holding certain leases of land, engaging in certain trades and professions, and possessing a horse of greater value than five pounds.
- 1795—** The Orange Order was founded to defend the Crown and protect the Protestant Ascendancy.
- 1798—** Wolfe Tone, the father of Irish republicanism, led the unsuccessful Rising for an independent Irish republic by the United Irishmen.
- 1800—** Passage of the Act of the Union made Ireland part of the United Kingdom. The Act also abolished the Grattan Parliament. Irish politicians elected to Parliament will only sit in Westminster.
- 1829—** The Great Liberator, Daniel O'Connell, led the fight to pass the Emancipation Act, which removed the anti-Catholic oath of office for Members of Parliament (MP) so Catholics

- could serve in Parliament. Afterward, O'Connell led a nonviolent, mass participatory democratic effort to repeal the Act of the Union that failed.
- 1845 – 1855—** An Ghorta Mor (the Great Hunger/Famine) reduced Ireland's population by one third. Over one million people died of starvation and disease, while two million emigrated.
- 1858—** The Fenian movement was established in Ireland as the Irish Republican Brotherhood. It was also established in the United States. The Fenian movement was based on the core belief that Ireland will only win freedom from Great Britain through the use of physical force/armed resistance.
- 1867—** A Fenian Rising in Ireland was defeated. Three "Manchester Martyrs" were executed for killing a policeman in Britain, while trying to free Fenian prisoners.
- 1882—** Charles Stewart Parnell, leader of the Irish Parliamentary Party (IPP), formed the Land League and gained passage of the Land Act, which provided tenant farmers with rights such as the assessment of fair rents and security against arbitrary evictions.
- 1884—** The Gaelic Athletic Association (GAA) was founded in Thurles, Co. Tipperary, to promote Gaelic culture and sports (hurling and football).
- 1886—** The first Home Rule Parliament for Ireland Bill was introduced by British Prime Minister William Gladstone. The bill was defeated in the House of Commons. Conservative Party leader Lord Randolph Churchill, father of future Prime Minister Winston Churchill, gave a speech to Orangemen in Belfast who opposed Home Rule for Ireland. He told them that "Ulster will fight, and Ulster will be right."
- 1892—** A second Home Rule Parliament for Ireland Bill was passed in the House of Commons, but defeated in the House of Lords.
- 1907—** Sinn Fein ("Ourselves Alone") was established as a nationalist political party alternative to the IPP.
- 1912—** A third Home Rule Parliament for Ireland Bill was introduced. After the power of the House of Lords to override bills passed by the House of Commons a second time was curbed, the Home Rule bill passed. It was due to become law in 1914. Sir Edward Carson organized the Ulster Covenant, which was signed by 450,000 unionists who pledged to resist Home Rule.
- 1913—** The Ulster Volunteer Force (UVF), an armed militia opposed to Home Rule, was founded in Ulster. In Ireland, nationalists founded the Irish Volunteers.
- 1914—** The Home Rule Parliament for Ireland Act was placed on hold due to commencement of hostilities in World War I. The Act's suspension was for the duration of the war.
- 1915—** The Irish Republican Brotherhood's Military Council started preparing for another Rising.
- 1916—** The Easter Rising commenced with the takeover of the General Post Office in Dublin and the reading of the Proclamation of the Irish Republic by Padraig Pearse. The rebels sought independence, not Home Rule. The Rising was crushed within six days by 30,000 British forces. Pearse surrendered to General John Maxwell. After holding court-martials, the British executed 14 leaders of the Easter Rising. This turned the tide of public opinion in favor of the rebels.
- 1918—** Immediately after the end of World War I, Prime Minister David Lloyd George called a general election. In Ireland, Sinn Fein wiped out the IPP by winning 73 seats to 6. Sinn Fein members elected to the Westminster Parliament refused to take their seats. Instead, they formed their own Parliament, the Dail Eireann.
- 1919—** The first Irish Dail convened in the Mansion House in Dublin and re-proclaimed a free and independent Irish Republic. On the same day, Irish Volunteers (IRA) killed two members of the Royal Irish Constabulary, marking the beginning of the Irish War of Independence.
- 1920—** The Government of Ireland Act passed in Westminster. It created the Northern Ireland statelet, partitioned six counties in Ulster from the rest of Ireland, and made them part of the United Kingdom.
- 1921—** The Anglo-Irish Treaty ended the Irish War of Independence. It created a 26 county Irish Free State. The treaty gave Ireland dominion status within the British Empire and cemented the partition of Northern Ireland. .
