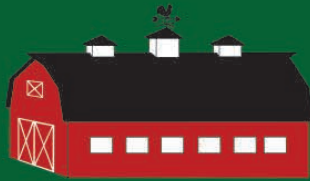

# Irish History # 64 - De Valera' U.S. Mission (Part 1)

When De Valera came to the United States in 1919, he came as President of the Irish Republic. In announcing de Valera's arrival in New York City, his friend Harry Boland said Irish President de Valera speaks "with an authority . . . equal to that of the President of the United States or the President of France or of Great Britain." The Irish Republic, however, "did not exist in the eyes of the law," and was not officially recognized by the U.S.

De Valera intended to change the U.S. position. One of the goals of his mission was to win U.S. support for Irish nationhood. He was not successful on this aspect of the mission. U.S. President Woodrow Wilson supported self-determination for other nations, but not for Ireland.

Another goal of the mission was to generate publicity for Irish independence and raise money for the war effort against British authorities by floating Irish bonds. On this, de Valera was successful. The announced fundraising target for the bond campaign was 10 million dollars, although the hope was for half that amount. Ultimately, \$5,123,640 was raised.

The vast majority of interest-bearing bonds were purchased in amounts of \$25 or less. Checks were made payable to Eamon de Valera. Bondholders received a certificate from the First National Loan of the Republic of Ireland, which was redeemable one year after the Republic was freed from "British military control." Bondholders, therefore, held a financial stake in Irish nationhood.

Justice Daniel Cohalan, head of the Friends of Irish Freedom organization, and John Devoy, Fenian leader of Clan na Gael, welcomed de Valera in NYC. In a short time, de Valera's ego led him to butt heads with the two men. De Valera believed he was in charge of all things Irish even in America. He expected Cohalan and Devoy to unconditionally accept his decisions and pronouncements.

In his first speech in NYC, de Valera established a theme for his U.S. trip - analogizing America's Revolutionary War with the war Ireland was fighting for its independence from Great Britain. "The very same catch cries and the very same tools were used by the English government against leaders of the American Revolution as are being used against us today," he said. He stated what he believed about the American people, that they would never "allow [themselves] to be made party to the suppression of the natural, God-given right of the Irish nation to its liberty."

In September, British authorities declared the Irish Dail Eireann illegal and ordered the arrest of its members. The move to outlaw the Dail came in response to the death of Intelligence Detective Patrick "the Dog" Smith. The squad formed by Michael Collins to combat British intelligence shot Smith for ignoring a warning to refrain from cooperating in the sedition prosecution of the editor of the Irish Volunteers' newspaper. (See Chapter 63) Smith's assassination was the first of many. Before he left for America, Eamon de Valera had introduced a motion passed by the Dail that "members of the police forces acting in [Ireland] as part of the forces of the British occupation be ostracized socially by the people." Smith was ostracized with "extreme prejudice."

In the view of many, de Valera represented a rogue government and an illegitimate nation. But, as he crisscrossed the country on a bond drive, hundreds of thousands of Americans with Irish roots turned out to hear him speak about Irish independence and nationhood. In October alone, he addressed large crowds in Philadelphia, Cleveland, Indianapolis, St. Paul and St. Louis. An estimated 50,000 attended his speech at Wrigley Field in Chicago.

In Wisconsin, the Chippewa Indian tribe made de Valera honorary chief, gave him a headdress and performed ceremonial dances in his honor. The audience applauded when he spoke: "I want to show you that though I am white I am not of the English race. We like you, are a people who have suffered. And I feel for you with a sympathy that comes only from one who can understand as we Irishmen can." After this empathetic connection with the plight of Native Americans, he asked for assistance. "I call upon you, the truest of all Americans . . . to help us win our struggle for freedom."

In Kansas City, de Valera interrupted a murder trial. The judge invited him to address those in attendance. It was reported the defendant shook de Valera's hand and said "you're the first President I ever met. So glad you came." In South Bend, de Valera attended a Notre Dame "Fighting Irish" football game. He received the Freedom of the City in Detroit.

Back on the east coast, he was given the Freedom of Jersey City. In Massachusetts, de Valera laid wreaths at the Minuteman Monument in Lexington and Bunker Hill in Boston. In Worcester, the mayor welcomed him as a war hero [the 1916 Easter Rising] and held a parade in



his honor. He received an honorary law degree from the College of the Holy Cross.

Wherever he went, he generated enthusiasm and money for the Irish cause. He reveled in the adulation. Problems existed, however, underneath the surface. Fractures arose in de Valera's support among Irish-American leaders. A split with de Valera came into the open when, in an interview with the New York Globe newspaper, he raised the prospect of Great Britain and Ireland co-existing in the same manner as the U.S. and Cuba. De Valera told the newspaper: "Why doesn't Britain do with Ireland as the United States did with Cuba? The people of Ireland would cooperate with their whole soul."

The news story portrayed the suggestion as an offer of an "olive branch." Some saw it as a withdrawal of "the demand that Ireland be set free to decide her own international relations." Cohalan and Devoy knew England would see it "as an offer of surrender." They were highly critical of the idea, because it called for "much less than an independent Ireland."

Devoy's newspaper, the Gaelic American, ran a headline, "De Valera Offers Settlement to England," and published Devoy's critical reply. De Valera clarified that he was only referring to one aspect of "Cuban-American relations in the aftermath of the Spanish-American War," and that was dealing with Cuba's vow to "not allow its territory to be used by any foreign power to attack America." Further public disagreement over the contentious matter ended for the sake of the ongoing war effort in Ireland. But the damage was done and, as we will see in the future, conflict over who was in charge of the movement in America continued.
